

## The 5<sup>th</sup> Annual Cambodian New Year Parade

Sunday, April 5<sup>th</sup>, 2009

Parade starts at 9:30 am on Anaheim Street  
From Junipero Avenue to MacArthur Park

**ENTRY:** COMPLETE AND RETURN THE ENTRY FORM BY **FRIDAY, MARCH 06<sup>th</sup>, 2009**.  
Parade orders and staging information will be sent to accepted entries 30 days prior to the parade.

### **RULES:**

1. All entries should have a positive theme which respects diversity, is non-controversial, and does not advocate any political candidate, proposition or position.
2. All participants must be uniformed, costumed and/or appropriated attired.
3. An entry is only for one organization with one identification banner.
4. Floats must be self-propelled and decorated with fire retardant materials.
5. Forward motion must be maintained throughout the parade route. No side-line handshake or physical contact with spectators allowed.
6. No alcoholic beverages allowed in the parade – **STRICTLY ENFORCED**.
7. Absolutely, no solicitation allowed along the parade route.
8. At no time is any unit allowed to hand out or throw anything along the parade route.
9. All participants must sign and submit the Consent/Waiver or Parental Consent/Waiver of Liability with the entry application.
10. All entries in the parade must be approved by the Parade Committee.
11. Only those entries stated on the application at time of submission will be allowed to proceed along the parade route.
12. The Parade Committee accepts no responsibility for false statements made by applicants or entrants.
13. Violations subject to disqualification.
14. A **NON-REFUNDABLE REGISTRATION FEE** \$150 non-profit, \$300 private agency/company per unit/entry/organization **MUST** be made payable to CAM-CC upon submission of the application along with a copy proof of IRS 501 (c) (3) non-profit agency/organization.
15. Parade will proceed **RAIN** or **SHINE**

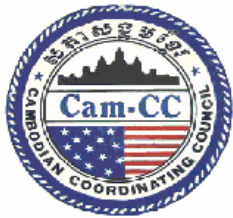
